

Privacy information

When you visit this website for the registration for "Global DPM Summit 2022" ("**Event**"), Merz Therapeutics GmbH, Eckenheimer Landstrasse 100, 60318 Frankfurt am Main, Germany ("**Merz**", "we") processes your personal data as controller (as defined in the General Data Protection Regulation (Regulation (EU) 2016/679; "**GDPR**")).

When this registration website ("**Website**") is accessed, the Merz servers automatically store various data about the system accessing the Website. This includes the type and version of the browser used, the operating system, the referral website from which the Website is accessed, the subpage of the Website accessed, the date and time of access, the IP address, the internet service provider and the size of transmitted data. Merz uses this data to enable access to the Website and to identify and correct any technical problems that may occur. In addition, Merz uses security and session cookies that are strictly necessary to operate the Website. The legal basis for collecting this information and for using security and session cookies is the provision of the service you have requested (Art. 6 para. 1 lit. b) GDPR).

To allow you to register for the Event, we need to collect your name, your (home) address, details about the flights you booked to and from the location of the Event, your email address, details about your department/affiliate and possible dietary restrictions/allergies. We need this personal data to organize your attendance at the Event and the related accommodation, e.g. for booking a hotel room. The legal basis for collecting and further processing your personal data is our performance of our agreement with you concerning your attendance at the Event (Art. 6 para. 1 lit. b) GDPR and, if you are an employee of Merz, Section 26 para. 1 sentence 1 of the German Federal Data Protection Act ("**BDSG**")).

If you declare your voluntary consent, we may also take pictures or video recordings during the Event. The pictures or recordings will focus on the presentation and the speaker; however, it is possible that other attendees are also visible in the pictures or recordings. The pictures or recordings can be presented during the Event and will otherwise only be used for internal purposes at Merz, meaning that they will be made available to Merz employees for training purposes. The pictures and recordings will not be published or otherwise shared with third parties. Your consent would be voluntary and not granting consent would not affect your employment or other contractual relationship with Merz. The legal basis for this processing is your consent (Art. 6 para. 1 lit. a) GDPR and, if you are an employee of Merz, Section 26 para. 2 BDSG). You can withdraw your consent at any time without affecting the lawfulness of the processing before the withdrawal.

For the organization of the Event, Merz cooperates with the agency METZLER : VATER live GmbH who will process your personal data in accordance with the instructions issued by Merz.

Further, we might share your personal data required for the registration for the Event with service providers organizing your accommodation. The legal basis for disclosing your personal data to these service providers is our performance of our agreement with you concerning your attendance at the Event (Art. 6 para. 1 lit. b) GDPR and, if you are an employee of Merz, Section 26 para. 1 sentence 1 BDSG).

We will store your personal data as long as required for the organization and performance of the Event. If you are an employee of Merz, please see the Privacy Notice for employees of Merz for further information about the processing and retention period of your personal data.

You might have the right to request access to, rectification or erasure of your personal data, restriction of processing of your personal data, data portability, and the right to withdraw your consent vis-à-vis Merz. You also have the right to lodge a complaint with the competent supervisory authority.
